# **ABOUT THE PROJECT**

#### Demands and needs met:

The project had three focus in Unimed Governador Valadares:

To establish the strategic planning;

To structure the Corporate Governance model;

Establish the Quality Management System (QMS) certificated by ISO 9001:2015.

The QMS allowed the recertification, in december 2017, of ISO 9001:2015. Four years ago, Unimed Governador Valadares had conquered the previous version, ISO 9001:2008.

The project also aims to receive the ONA (Brazilian National Health Accreditation Organization) in 2018 and comply with Normative Resolution 277/2011 of the National Supplementary Health Agency (ANS) in 2019.

Through these three goals, the project of Unimed Governador Valadares sought to create the strategic structure of the cooperative. This construiction was based in a Cooperative Governance, implemented with the support of the Unit Interact Belo Horizonte. These actions are presented in the Quality Management System, focused in the result of attendance of the cooperated members needs.

### **ABOUT THE IMPLEMENTATION**

The project included a series of activities. Among them, social seminars were held (with customers, non customers, services providers and partners) and intern seminar (with coordinators, managers and directors).

These actions contributed to the design of the maps' structure on SA Strategic Adviser, with the purpose of monitoring. Besides that, deadlines were created aiming the continuous improvement (annually) and critical analysis by the high management (semiannually).

## **RESULTS**

The project allowed a better access to the Company's information in a integrated way. Besides that, insured a control of the process and the assertive decision-making in all the process of the cooperative management. These benefits reflected in changes for a better controll and improved access to process controls. The project took two years of structuring with the SA Strategic Adviser.

The partnership between Unimed Governador Valadares and Interact Belo Horizonte already takes ten years, without autonomy of the system in the begging. Unimed Governador Valadares conquered ISO 9001:2008 certification in the begging of 2014 and the recertification from ISO 9001:2015 in 2017. Also, in 2013, it conquered the gold stamp in the Corporate Governance Award
